- 3 - That the persons entitled to vote at a Polling Station are the Electors, whose names are on the current Register of Electors together with the Balancing List (if any), for the Polling District opposite to that Station as set out in Column 3 of the Schedule hereto, but Excluding persons against whose names the letters (E) or (L) or (J) or (S) appear.
